## Oxford and Cambridge Act 1923

## Church Commissioners

9 Orders confirming Schemes of the Church Commissioners for:

1. revoking an earlier Scheme and appropriating a larger part of the churchyard of St Bartholomew's parish church, Allens Cross to use for access purposes, diocese of Birmingham;
2. appropriating part of the churchyard of St Mary's parish church, Bitteswell to use as a pedestrian footpath, diocese of Leicester;
3. creating a new benefice of Oswestry Holy Trinity and designating its first incumbent, diocese of Lichfield;
4. terminating the team ministry established for the benefices of Gosberton, Gosberton Clough and Quadring and of Surfleet, and uniting the benefices of Pinchbeck and of Surfleet to create the new benefice of The Glen Group, diocese of Lincoln;
5. uniting the benefices of St Saviour, Upper Chelsea and of St Simon, Upper Chelsea to form the new benefice of Upper Chelsea, diocese of London;
6. altering the name of the benefice of St Agnes, Birch with St John with St Cyprian, Longsight to "St Agnes, Birch-in-Rusholme, with St John with St Cyprian, Longsight" and creating a new parish with the same name; diocese of Manchester;
7. appropriating part of the churchyard of St James' Church, Calderbrook and vesting it for disposal in the Diocesan Board of Finance, diocese of Manchester;
8. uniting the benefices of Wendover and of Halton to create the new benefice of Wendover and Halton, diocese of Oxford; and
9. uniting the benefices of Christ the King, Meltham and of Helme to create the new benefice of Meltham, Christ the King, uniting the parishes of Christ the King, Meltham and of Helme, and designating the first incumbent of the new benefice.
