Church Commissioners

Seven Orders confirming schemes of the Church Commissioners for :

1. creating the new benefices of Newchurch-in-Pendle and of Barrowford St Thomas and Newchurch-in-Pendle St Mary, creating the new benefice and parish of Higham St John the Evangelist and the new benefice of Fence-in_Pendle St Anne and Higham St John the Evangelist, altering the name of the benefice and parish of St Leonard, Padiham and establishing a group ministry for the new benefices of Barrowford etc and of Fence-in-Pendle etc, diocese of Blackburn;
2. terminating the team ministry established in 1991 for the benefice of Totnes, Bridgeton and Berry Pomeroy and Dartington, uniting that benefice with the benefice of Marldon and establishing a team ministry for the area of the new benefice, diocese of Exeter;
3. uniting the benefices of Leatherhead and of Mickleham, diocese of Guildford;
4. creating the new benefice of Lydbury North with Edgton and uniting it with the benefice of Bishop's Castle with Mainstone, diocese of Hereford;
5. uniting the parishes of Lumb and of St Nicholas with St John, Newchurch, and declaring redundant the church of St Michael, the parish church of Lumb, diocese of Manchester;
6. terminating the group ministry established in 1970 for various benefices in Stevenage, diocese of St Albans;
7. uniting the parishes of Bradfield St George and of Little Whelnetham, diocese of St Edmundsbury and Ipswich;
